The first day of competition at the USA Canoe/Kayak Sprint National Team Trials featured the strength of veteran leaders and introduced a wave of new talent to the National Program. Aiming for her third consecutive Olympic appearance at the 2012 Games in London, <u>Carrie Johnson</u> (San Diego, Calif.) surged to an early lead in the Women's K1 500 meter event and held off the field for a dominant win in the day's most anticipated race.

In the Menâ€^{Ms} K1 1,000 meter event, <u>Luke Michael</u> (Sydney, Australia/Hawaii), a newcomer to the U.S. National Program, captured top honors in his first Team Trials as a U.S. Citizen. Michael later teamed up with brother, <u>Jake</u> (Sydney, Australia/Hawaii), taking Gold in the Menâ€^{Ms} K2 1,000 meter race.

"Luke and Jake have infused our program with a new level of intensity and focus on and off the water,â€said William Irving, USA Canoe/Kayak's National Teams Director. "Their performance along with their teammates will bring the United States back to a fielding a competitive team boat on the international stage.â€

Day Two at the Sprint Trials will feature 200 meter racing, the newest Olympic event as well as the Stand Up Paddle Board racing at the Chula Vista Olympic Training Center on Lake Otay. The second and final day of competition will finalize selection of the Senior National World Cup Team as well as the Junior National Team, which will compete at the Junior World Championships this summer in Germany.

Over one hundred of the best U.S. sprint athletes will take to the water this Friday and Saturday for the USA Canoe/Kayak 2011 Sprint National Team Trials at the Olympic Training Center in Chula Vista, Calif., April 22-23.

The event represents one of the first steps toward achieving the Olympic dream. The elite athletes will compete for spots on the 2011 U.S. Sprint National Team, which will participate in the upcoming World Cups. The Trials mark the beginning of the process of naming the team for the 2011 World Championship and the 2011 Pan American Games, which are currently only two events in which the U.S. can qualify spots for the London 2012 Olympic Games.

â €eSince the end of the 2010 World Championships, athletes have turned their attention to the 2011 season and this day of qualifying for the World Cups,â €said USA Canoe/Kayak National Teams Director William Irving. â €eThe athletes have poured numerous hours of training both on and off the water to prove that they belong amongst the top paddlers in the World. The athletes are focused on qualifying boat places for the 2012 Olympic Games, which is the end result that all of them are looking towards.â€

Highlighting the field will be eight members of the 2010 National Sprint Team looking to book their tickets to this summer's World Cup circuit. Two-time Olympian Carrie Johnson (San Diego, Calif.) leads the way after a 2010 season that included three Pan American medals and a K1 500m National Championship. Other notables include Emily Vinson (Gainesville, Ga.), Ariel Farrar-Wellman (Bethesda, Md.) and two-time 2010 PanAm medalist Maggie Hogan (San Diego, Calif.).

On the menâ€[™]s side, <u>Ryan Dolan</u> (Kailua, Hawaii) and <u>Morgan House</u> (Gainesville, Ga.) will be tough to beat after winning two medals apiece at the 2010 National Championships. Other notables include Ryanâ€[™]s brother <u>Pat Dolan</u> (Kailua, Hawaii), <u>Tim Hornsby</u> (Atlanta, Ga.), and Austrialian-American twins <u>Luke</u> and <u>Jake</u> <u>Michael</u> (Sydney, Australia).
